

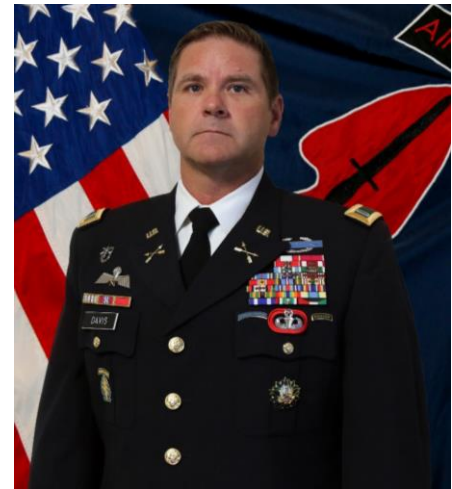

CW5 ROBERT A. DAVIS COMMAND CHIEF WARRANT OFFICER

Chief Warrant Officer 5 (CW5) Robert A. Davis enlisted in the U.S. Army on August 30, 1988 and upon completion of training, he was assigned to the 1st Cavalry Division at Fort Hood, Texas as a Wheel Vehicle Mechanic, serving in Saudi Arabia and Iraq during Operations DESERT SHIELD and DESERT STORM. In 1992, CW5 Davis was assigned to the 101st Corps Support Group at Fort Campbell, Kentucky where he served in Somalia during Operation CONTINUE HOPE in 1993. In 1994, CW5 Davis attended Special Forces Assessment and Selection and then the Weapons Sergeant Qualification Course in 1995. Upon completion, he was assigned to 2nd Battalion, 3rd Special Forces Group (Airborne) as a Weapons Sergeant on Special Forces Operational Detachment-Alpha (SFODA) 346 and then SFODA 341, deploying for numerous missions in western Africa.



In April 2001, CW5 Davis attended Warrant Officer Candidate School and the Special Forces Warrant Officer Basic Course. Upon completion, he was again assigned to 2nd Battalion, 3rd Special Forces Group (Airborne) as the Assistant Detachment Commander for SFODA 362. In June 2006 CW5 Davis assumed duties as the Company Operations Warrant Officer for Operational Detachment Bravo 3230. Following this, CW5 Davis was then assigned to the U.S. Army John F. Kennedy Special Warfare Center and School at Fort Bragg, North Carolina in September of 2008, where he served as the course director for the Special Forces Warrant Officer Technical and Tactical Certification Course.

CW5 Davis returned to 3rd Special Forces Group (Airborne) in July 2011 to serve as 3rd Battalion's Operations Warrant Officer and Senior Warrant Officer Advisor until February 2013. CW5 Davis was then assigned to the 3rd Special Forces Group (Airborne) headquarters to serve as the Group Operations Warrant Officer until May 2015. From May 2015 to May 2017 he served as the Group Command Chief Warrant Officer. Throughout his service in 3rd SFG (A) he has deployed numerous times in support of Operation Enduring Freedom, operations throughout Africa, and at the Special Operations Command Forward - North and West Africa.

In July 2017, CW5 Davis was selected to serve as the Command Chief Warrant Officer for the 1st Special Forces Command, until April 2019 when he was assigned to Headquarters, Department of the Army, G 3/5/7, where he served in the G37 Training Directorate. In October 2020, CW5 Davis was selected as the Command Chief Warrant Officer for United States Army Special Operations Command, where he currently serves.



CW5 Davis' awards and decorations include the Army Distinguished Service Medal, Legion of Merit, Bronze Star Medal (2OLC), Meritorious Service Medal (2OLC), Joint Service Commendation Medal (2OLC), Army Commendation Medal (2OLC) with Valorous Device, Southwest Asia Service Medal, Afghanistan Campaign Medal, United Nations Service in Somalia Medal, NATO Medal, Global War on Terrorism Medals, Kuwaiti Liberation Medals, Combat Infantryman Badge, Expert Infantryman Badge, Special Forces Tab, Ranger Tab, Master Parachutist Badge and Air Assault Badge.
